Payments are due within 30 days of the statement date. A late fee of 1.5% per month will be charged after the due date. A \$35 fee will be charged on returned checks. Members with delinquent accounts will be subject to suspension of membership rights, including but not limited to: access to KICA recreational facilities, vehicle barcodes and voting rights.

# WHAT ARE MY ASSESSMENTS FOR?

#### **General Assessments**

Paid by all members, the general assessment covers the maintenance of common properties (e.g., association owned/leased roads, landscaping, lakes, leisure trails, signage and KICA boardwalks), security operations (e.g., gate access, patrols and commercial access) and administrative operations (e.g., insurance on common properties, legal and accounting services).

#### Sandcastle/Pool Amenity Assessment

This member assessment funds the operation and maintenance of the Sandcastle facility and pool.

### Reserve Assessment (formerly known as Supplemental Annual Assessment)

The Reserve Assessment strengthens and diversifies the revenue stream supporting KICA's reserve fund. Reserve funds are used to repair and replace infrastructure on the island.

# Second Gate Segment Assessment

The Second Gate Segment Assessment is paid by members who own property behind the Vanderhorst gate (V-gate) and covers the operation and maintenance of that gate.

# Additional Fees as Designated

### Joint Member Administrative Fee: \$150

This fee is charged on properties owned by multiple households or entities. The property will be charged \$150 for each additional owner household to cover the administrative costs associated with multiple ownership. New for 2018, this fee provides each owner of record access to The Sandcastle.

#### Preserve Segment Assessment: \$110 unimproved, \$220 improved

Paid by members in the Preserve, this assessment covers the repairs and maintenance to the common area fences and landscaping.
