The 2018 KICA Membership is a one-time opportunity for KICA property owners to join the Governor's Club as a Pool-only member while the KICA pool is closed. This membership EXPIRES ON JUNE 30, 2018.

The cost of the membership is \$275 + tax (\$288.75). The privileges include access to the three Kiawah Island Golf Resort pools at Night Heron Park and the West Beach Pool. Guests may accompany you to the pool. The guest fees are \$12 per day for anyone over the age of 12 and \$7 per day for ages 4-12. Children under 4 are free.
